## Dual Credits

We are looking forward to continuing our partnership with NorQuest College in the coming year. We are adjusting our timetable in an attempt to enable more Grade 12 students the opportunity to complete English 30-1 in semester 1 and ENGL 1011 in semester 2.

## PACK Day Attendance 2014-2015

The only way to accurately determine student attendance is to manually assess each session, include the excused students whose parents contacted the school and compare that to the overall school registration count. The overall registration count is that indicated on PowerSchool for that time period.

Other high schools that use Flex Blocks have been reporting attendance in the 45-60\% range.

What the data indicates is that there is not a set pattern for attendance, as no trend is apparent. Overall, the data shows that attendance is very strong and is one primary indicator of the success of PACK Day in the first year.

## PACK Day Analysis - May 2015

We have been through 8 PACK Days this year and it has evolved considerably as we progressed through the year. We experienced successes and challenges with each day, though overall it was a strong program that offers many opportunities for our students, faculty and the communities.

## MCHS Religion Retreat

This takes place May 19 to 21 at Camp Encounter involving Grade 9-12 students, our faculty and the Oblate Youth Ministry.

## GSACRD Emergency Drills

All GSACRD schools have been working with Hour Zero to revise the safety planning process and standardize them in each school. We are participating in a format that many school districts and emergency providers (Fire, Police and EMS) are currently involved with. We will be finishing the year with a Shelter-in-Place (tornado drill) and a Fire Evacuation.

A GSACRD document, School Emergency Program: A Guide for Parents and Guardians was emailed to all parents.

## MCHS Faculty Engagement (handouts provided)

Since 2008 GSACRD has utilized Gallup and their Q12 Survey to analyze staff engagement results for each school and the district as a whole. Individual staff responses are calculated on individual schools and then an average is calculated for the overall district.

The Gallup Questions are questions that Gallup has consistently found measure the aspects of employee engagement that link to business outcomes. Gallup tested thousands of questions on millions of employees to find the right questions with the exact wording that provided the highest correlation to business results most companies regularly measure —profitability, productivity, turnover, and safety. This survey has been conducted annually and the results for MCHS and for the district are provided in the following chart.

## District/Provincial Budget Overview

The incoming government has extended the budget submission deadline for schools and districts to June 30 from May 30. This will allow schools and districts additional time to balance their budgets. Right now we are still working under the last lawful order of the previous Minister of Education and the financial restrictions that were in place with the outgoing government. It is hoped that in the coming weeks/months that revisions to the provincial budget will enable schools and districts to continue to move forward with building programs for students.

## School Start-Up - August 2015

As in the previous three years, we are setting aside days prior to the first day of school, in which students and parents come to school to address several required start-up procedures. Previously we had used two days for this and we are going to expand that to three days for student registration:

- Course changes - any necessary
- All student timetables will be mailed by July
- Text book pick-up
- School fees payment
- Fees paid online greatly speeds up this process for parents as this can be the most time consuming part of this start-up process
- Athletic wear pick-up
- Student photos - for Student Cards, year book and the parent package
- Locker assignments


## Monday, August 24 - Grade 9 and 11 students

Tuesday, August 25 - Grade 10 and 12 Students
Wednesday, August 26 - Students new to GSACRD (individual appointments)

It is critical that all students and parents are part of these August 24,25 and 26 start-up processes. Having all students ready to go
with photos, lockers, textbooks and the correct courses on day one of the school year is extremely important. We have been averaging over $90 \%$ of our students and parents participate on these days in the past three years and we are looking to improve upon last year and make it more efficient.

## Staggered Entry - First Day (Monday, August 31)

As part of our mandate to be a safe and caring school, we are continuing with our practice to stagger the first day for our Grade 9 and 10 students. This permits students to better acclimatize to either their new school environment (Grade 9's), or the new reality of high school courses (Grade 10's).

- August 31 - Grade 9's (8:00-12:00) and Grade 10's (12:00-3:00)
- Lunch will be provided for all the Grade 9's and 10's
- September 1 - Full day for all students


## MCHS School Discipline Report -

For the Period of August 31, 2011 to May 14, 2012 there were 74 suspensions earned by students.
For the period of August 31, 2012 to May 21, 2013 there were 62 suspensions earned by students.
For the period of August 31, 2013 to May 20, 2014 there were 34 suspensions earned by students.
For the period of August 31, 2014 to May 19, 2015 there were 26 suspensions earned by 21 students.
